**FACILITY** Competition course is 8 lane 25 yard pool. Water depth at the competition start end is a minimum of 7 feet and the turn end is a minimum of 7 feet. Non-turbulent lane lines and regulation starting blocks will be used. Warm up and warm down will be available in a separate 8 lane 25 yard course. A Colorado timing system with automatic touch pads and backup buttons will be used. In addition, there is a full color alpha-numeric dual 8 lane LED scoreboard that will be used.

**MEET FORMAT** This is an Open timed final session to be held in short course yards (SCY).

**RULES** Current USA Swimming rules will govern the meet. Fly-over starts and/or chase starts may be used.

**CODE OF SANCTION**

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or swimmer's legal guardian to ensure compliance with this requirement. The completion course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming. Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited.

**CAMERA ZONES**

Per Florida Swimming Rule 223.12, Meet Management shall designate and inform the public of "Camera Zones" at each swim meet where both still photography and video photography of a race or race competitor in a race may be taken. Acceptable "Camera Zones" may include, but are not limited to the side course of the pool, team gathering areas, concession areas, turn end of the competition course when not in use as a "start-end", etc. Meet Management shall designate "Non-Camera Zones". Under NO circumstances will Camera Zones include the area immediately behind the starting blocks at either end of the racing course(s) while they are in use for "race starting purposes" during competition and warm ups, locker rooms, rest rooms, or any other dressing area. Any individual failing to abide by this rule could be subject to the Florida Swimming Code of Conduct violation as defined in Rule 239.2.

**DRONES**

Per USA Swimming Rule 103.13, DRONES, operation of a drone, or other flying apparatus is prohibited over the venue any time athletes, coaches, officials and/or spectators are present, regardless of whether the venue is indoor or outdoor. Exceptions may be granted with prior written approval by the Program Operations Vice Chair

**ELIGIBILITY**

This meet is open to all currently registered USA Swimming swimmers. 2017 USA-S registrations will not be accepted on site.

**ENTRY LIMITATIONS**

Entries will close upon receipt of the team that puts entries over the four-hour time limit per session. Swimmers may compete in no more than six (6) individual events.

**DISTANCE EVENTS**

Swimmers entered in distance events will need to provide their own counters.

**ENTRY DEADLINES**

Entries must be received by 9:00 pm on Thursday, July 27, 2017 via email to Victoria Culbertson ([meetsupport@sportstiming.com](mailto:meetsupport@sportstiming.com)). Changes to event selections will be allowed on pool deck during the Aquatica Splash meet up until 2:00pm on Saturday, July 29, 2017. No phone or fax entries accepted.

**VISITING OFFICIALS** Visiting teams are encouraged to bring USA-S certified Florida Swimming (or other LSC) officials to assist with officiating the meet. Teams should email names and certification levels of their team officials to:

**SEEDING** The conforming time standard for this meet is short course yards. Conversions may be made using the formula in the current Florida Swimming Handbook.

**SCRATCHES** TIMED FINALS – There is no penalty for scratching on the block in an event.

**SCORING** No scoring

**AWARDS** No awards

**TEAM REP** Prior to the start of the meet, the name of one person other than the coach who will check with the referee about any matter pertaining to the meet must be given to the referee. Only that person and the coach will be recognized.

**COACHES/OFFICIALS** All coaches and officials on deck must be registered and certified with USA Swimming. Coaches and officials shall wear USA Swimming registration cards in a conspicuous location at all times while on deck during the meet or be able to show proof of membership via the Deck Pass app. There will be a coach/general meeting at the date and time listed in the Deadline and Meeting Summary. Other meetings may be held at the meet referee’s discretion. Meet Management requests that at least one coach representative from each team attend all coach’s meetings. Official Briefings will be held prior to each session at the times listed in the Deadline and Meeting Summary.

- Location:** YMCA Aquatic Center, Orlando, Florida
- Time:** Approximately 15 minutes after the conclusion of the YCF Short Course Splash timed final session.
- Pool:** Two 8-lane, 25-Yard courses, one for competition and one for warm up/warm down. Colorado Timing System.
- Eligibility:** Open to all swimmers already properly entered in the YCF Short Course Splash meet.
- Entry Limit:** Six (6) individual events per day, including events swum in the YCF Short Course Splash meet. The order of events will be swum only one time.
- Entry Fees:** \$10 per event. Cash only will be accepted.
- Entries:** Will be accepted at the Clerk of Course and will close one hour before the projected start of the time trials.
- Seeding:** Enter with 25 yard times. **\*1000/1650 distance events** will be offered and may be combined with the slowest heat(s) during the regular timed final session until available lanes are filled. Time trial swimmers will not be scored.
- Scratches:** No penalty for scratching at the block.
- Rules:** Current USA Swimming rules will apply.
